## **What is Relationship and Sex Education?**

Relationship and Sex Education (RSE) is lifelong learning about physical, sexual, moral and emotional development. It is about the understanding of the importance of stable loving relationships, respect, love and care for family life. It involves acquiring information, developing skills and forming positive beliefs, values and attitudes.

## **What is Health Education?**

Health Education is the teaching of the characteristics of good physical health and mental wellbeing. Pupils are taught about the benefits and importance of daily exercise, good nutrition and sufficient sleep and have the language and knowledge to understand the normal range of emotions that everyone experiences.

## **Policy Statement**

Through a whole-school approach, we aim to equip pupils with the knowledge, skills, attitudes and values they need to lead safe, healthy, fulfilling and responsible lives.

Our curriculum is based on the CORAM SCARF programme and reflects the school's value, ethos and safeguarding responsibilities.

RSE is taught within the Personal, Social, Health and Economic (PSHE) education curriculum. In addition, some aspects of the RSE programme will be covered through:

- Science curriculum

## **Aims**

The aims of Relationship and Sex Education (RSE), and Health Education at our school are:

- Provide a consistent standard of relationships and sex education, and health education across school from nursery to year 6.
- Help pupils develop feelings of self-respect, confidence and empathy
- Promote responsible behaviour

- Develop communication skills and assertiveness skills so that children cope with the influences of their peers and the media
- Teach pupils the correct vocabulary to describe themselves and their bodies
- Provide a framework in which sensitive discussions can take place
- Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- Give pupils an understanding of reproduction and sexual development
- Provide all pupils with knowledge, skills and attributes that will enable them to make positive and healthy choices concerning relationships as they grow up and deal with risk

### **Statutory Requirements**

### **Roles and Responsibilities**

**The governing board will be responsible for:**

- Playing an active role in monitoring, developing and reviewing the policy and its implementation in school.
- Appointing a link governor for RHE who supports the school and monitors any aspects of RHE included within the SIP.
- Ensuring all pupils make progress in achieving the expected educational outcomes.
- Ensuring the curriculum is well led, effectively managed and well planned.

- Evaluating the quality of provision through regular and effective self-evaluation.
- Ensuring teaching is delivered in ways that are accessible to all pupils with SEND.
- Providing clear information for parents on subject content and their rights to request that their children are withdrawn from sex education teaching.
- Making sure the subjects are resourced, staffed and timetabled in a way that ensures the school can fulfil its legal obligations.
- Creating and keeping up to date a separate written statement of this policy and ensuring the statement is published on the school's website and provided free of charge to anyone who requests it.
- Ensuring that all staff receive ongoing training on issues relating to PSHE and RHE and how to deliver lessons on such issues.
- Ensuring that all staff are up to date with policy changes, and familiar with school policy and guidance relating to RHE.

**The headteacher will be responsible for:**

- The overall implementation of this policy.
- Ensuring adequate time on school timetable to deliver RHE as a statutory curriculum subject.
- Providing support to staff members who feel uncomfortable or ill-equipped to deal with the delivery of RHE to pupils; for example, if staff do not feel that their training has been adequate or that aspects of the curriculum conflict with their religious beliefs.
- Ensuring that parents are fully informed of this policy and the RHE resources are available to parents beforehand.
- Discussing and reviewing requests from parents to withdraw their children from sex education teaching.
- Organising alternative education for pupils, where necessary, that is appropriate and purposeful.
- Reporting to the governing board on the effectiveness of this policy.
- Reviewing this policy on an annual basis.

**The RHE subject leader will be responsible for:**

- Overseeing the delivery of the subjects.
- Ensuring that staff values and attitudes will not prevent them from providing a balanced RHE in school.

- Providing the agreed vocabulary to be used during the lessons to ensure a consistent approach.
- Ensuring the subjects are age-appropriate and high-quality and up to date.
- Ensuring teachers are provided with adequate resources to support teaching of the subjects.
- Ensuring the school meets its statutory requirements in relation to the relationships, and health curriculum.
- Ensuring the relationships and health curriculum, as well as any optional sex education, is inclusive and accessible for all pupils.
- Working with other subject leaders to ensure the relationships and health curriculum complements, but does not duplicate, the content covered in the national curriculum.
- Liaising and working in partnership with parents and carers to support further conversations at home and to share the resources ahead of teaching upon request.
- Monitoring and evaluating the effectiveness of the subjects and providing reports to the headteacher.

**The SENCO will be responsible for:**

- Advising teaching staff how best to identify and support pupils' individual needs.
- Advising staff on the use of TAs in order to meet pupils' individual needs.
- Ensuring that the needs of vulnerable pupils are taken into consideration in designing and teaching these subjects.

**The appropriate teachers will be responsible for:**

- Delivering a high-quality and age-appropriate relationships and health curriculum in line with statutory requirements.
- Using a variety of teaching methods and resources to provide an engaging curriculum that meets the needs of all pupils.
- Ensuring they do not express personal views or beliefs when delivering the programme.
- Modelling positive attitudes to relationships, sex and health.
- Responding to any safeguarding concerns in line with the Child Protection and Safeguarding Policy.
- Acting in accordance with planning, monitoring and assessment requirements for the subjects.
- Liaising with the SENCO to identify and respond to individual needs of pupils with SEND.

- Working with the RHE subject leader to evaluate the quality of provision.

**Parents will be responsible for:**

- Supporting their children through their personal development and the emotional and physical aspects of growing up.
- Ensuring that they are aware of curriculum content, organisation and delivery.
- Fostering an open home environment where pupils can engage, discuss and continue to learn about topics that have been taught in school.
- Liaising with the school to seek additional support if needed.

**Curriculum**

Our curriculum follows the CORAM SCARF framework and is carefully sequenced to ensure knowledge builds progressively from EYFS to Year 6. Learning is organised through the six SCARF themes alongside the National Curriculum for Science – Statutory.

It includes:

- Relationships Education
- Health Education
- Sex Education

Relationships Education is compulsory in primary schools. Pupils will be taught:

- What healthy relationships look like.
- The characteristics of positive relationships.
- The importance of kindness, honesty and respect.
- How families can differ while providing love and care.
- How to resolve conflict.
- How to seek help if worried about themselves or others.
- Online relationships and digital safety.
- Respectful behaviour towards others.

Health Education. Pupils will be taught:

- Mental wellbeing
- Emotional literacy
- Healthy lifestyles

- Physical activity
- Healthy eating
- Sleep
- Personal hygiene
- First aid awareness
- Internet safety and harms
- Substance awareness
- Health-related decision making

Sex Education. Pupils will learn about:

- Human reproduction
- Conception and birth
- Physical and emotional changes during puberty
- Personal hygiene
- Body ownership and consent
- Respectful relationships

Parents have the right to request withdrawal from non-statutory sex education components where applicable. Request should be made in writing to the Headteacher.

Parents cannot withdraw children from:

- Relationships Education
- Health Education
- National Curriculum Science

### **Delivery of the curriculum**

Our RSE curriculum will be delivered in an age appropriate and sensitive manner by class teachers. Teaching is normally taught in mixed gender groups, though some content may be covered in single sex groups e.g. menstrual hygiene, single sex question sessions, etc

A range of teaching methods which involve children's full participation are used. These include use of video clips, written activities and discussion.

Pupils will be taught the facts and the law about sex, sexuality, sexual health and gender identity in an age-appropriate, inclusive and respectful way. We will endeavour to support all pupils to feel that the content is relevant to them and their developing sexuality.

At the point we consider it appropriate to teach pupils about sexual relationships, we will ensure that LGBTQ+ content is fully integrated into the sex and relationships curriculum.

### **Inclusion and SEND**

We are committed to ensuring that all pupils can access the curriculum regardless of gender, race, religion or belief, disability, sexual orientation or family circumstance. Teaching will be inclusive and adapted appropriately to meet the needs of pupils with SEND.

### **Equalities and Diversity**

The school understands its responsibilities in relation to the Equality Act 2010, specifically that it must not lawfully discriminate against any pupil because of their protected characteristics. Planning and resources are reviewed to ensure they comply with the equalities legislation and the school's equal opportunities policy. Topics are presented using a variety of views and beliefs so that pupils are able to form their own, informed opinions but also respect others that may have different opinions.

The personal beliefs and attitudes of staff delivering SRE will not influence the teaching of the subject in school. We aim to value and celebrate religious, ethnic and cultural diversity and encourage activities that challenge stereotypes and discrimination and present children with accurate information. We do not use RSE as a means of promoting any form of sexual orientation.

### **Sensitivity**

Pupil's questions will be dealt with honestly and sensitively and in an age-appropriate way. During more sensitive lessons, pupils will be asked to write questions down anonymously. Teachers will then discuss them as appropriate while maintaining professional boundaries and safeguarding responsibilities. Ground rules will be established for all lessons.

If any questions raise safeguarding concerns, teachers will talk to the Designated Safeguarding Lead.

### **Safeguarding**

The RSHE curriculum contributes significantly to safeguarding.

Teachers will help pupils to:

- Recognise abuse and exploitation
- Understand healthy and unhealthy relationships
- Recognise inappropriate behaviour.
- Understand consent and personal boundaries.
- Know where and how to seek support.

Teachers need to be aware that effective relationships and sex education, which brings an understanding of what is and is not acceptable in a relationship, may lead to a disclosure of a child protection issue. The staff member should raise any safeguarding concerns with the Designated Safeguarding Lead.

### **Consultation with parents**

The school understands the important role parents play in enhancing their children's understanding of sex and relationships. Similarly, we also understand how important parent's views are in shaping the curriculum. We want to build a positive and supporting relationship with the parents of children at our school through mutual understanding, trust and co-operation.

In promoting this objective, we:

Will carry out our statutory duty to consult with parents and governors on the content of this policy

Inform parents about the school's SRE Policy; this includes informing parents by letter before beginning to teach a unit on sex/health education

Answer any questions that parents may have about SRE and provide opportunities to view the resources that are used in lessons

### **Parental Concerns and withdrawing from the subjects**

Relationships education, health education and the science curriculum is statutory at primary school age and parents do not have the right to withdraw their children.

As sex education is not statutory for primary school age children, other than what is taught as the science curriculum, parents have the right to request to withdraw their child from all or part of the sex education curriculum. The head teacher will discuss the request with the parent and, if appropriate, their child and ensure their views are considered and an appropriate decision made.

### **Behaviour**

The school has a zero-tolerance approach to bullying. We aim to foster a culture based on mutual respect and understanding for one another. Any bullying incidents caused as a result of the relationship, sex and health education programme, such as those relating to sexual orientation, will be dealt with as seriously as other bullying incidents within the school. All such occurrences should be reported to a member of school staff.

### **Monitoring and Review**

The delivery of the RSE curriculum is monitored by the Senior Leadership Team members through, for example, learning walks and lesson observations.

This policy will be reviewed on an annual basis by the Headteacher and Governing Board.
